**Probable Cause**

**REQUEST FOR NO BOND UNTIL FIRST APPEARANCE**

On Thursday, December 25, 2025, at approximately 8:59 am while I was completing a traffic stop on State Road 44. I was dispatched to assist [REDACTED] on a traffic stop on Interstate 95 (State Road 9) southbound at mile marker 257 near the Port Orange Exit in Volusia County. [REDACTED] initiated the traffic stop for unlawful speed, at which point the vehicle failed to stop and obey [REDACTED] marked patrol car (FHP1116), bearing prominent black and tan colors, agency insignia, with emergency lights and siren activated for the traffic stop. The vehicle that [REDACTED] was attempting to stop was a silver Mercedes 4 door sedan with a Florida tag# [REDACTED] with dark tinted windows.

I immediately began to travel east on State Road 44 and stopped at the entrance ramp southbound on Interstate 95 at mile marker 249 waiting for the vehicle with all my emergency lights activated. The reason why I was waiting was because the vehicle was fleeing from [REDACTED] at a consistent speed of 130+ mph in a posted 70 mile per hour speed, while driving on the shoulder on the roadway in a reckless manner with no regard for the safety of all drivers occupying the roadway.

When the driver observed my vehicle south of the mile marker 249 overpass, it changed from the outside lane to the middle lane, at which point I began to enter the road and attempted to stop the vehicle. My patrol vehicle (FHP1206) is marked with agency insignia, and I was utilizing emergency lights / siren when I attempted the traffic stop. The driver refused to stop when ordered, accelerating faster to approximately 140 miles per hour, showing no regard for other traffic while continuing to drive in an extremely reckless manner (running several other vehicles off the roadway, using the emergency shoulder to pass traffic at dangerously high speed with no regard for her own or the safety of others).

After approaching and entering Brevard County, (mile marker 233) the driver continued operating her vehicle extremely recklessly, at which point we began to control vehicles by using the left side of the southbound, inside lane. While the vehicle was traveling on the inside lane at mile marker 220 [REDACTED] attempted to terminate the pursuit by conducting a PIT (Precision Immobilization Technique) maneuver on the right side of the vehicle. The vehicle then rotated back onto the roadway where it collided with [REDACTED] patrol vehicle. The momentum from the PIT caused both vehicles to travel onto the left shoulder, where the FHP patrol vehicle, and suspect vehicle collided with the center median guardrail.

At the time the PIT was attempted, I was behind the was behind the silver sedan I swerved to the middle lane to avoid colliding with both vehicles. I then pulled over to the left shoulder and as I exited my patrol vehicle, I observed a white Hispanic female, later identified as the driver, exit from the vehicle driver's door, where I placed her under arrest without further incident.

██████████ ordered the passenger to exit from the left-rear of the vehicle, and upon placing the passenger in custody, ██████████ then collapsed to the ground due to obvious injury from the vehicle contact, losing consciousness while first-aid was provided.

██████████ was transported to Holmes Regional Medical Center with serious injuries, ██████████

I did confirm that the female driver was a white Hispanic female by the name of SUNDARA, ESPERANZA, GARZA with a Florida DL (██████████). She was not wearing a seatbelt at the time she was driving, and was in actual physical control of a motor vehicle, committing the felony crime of aggravated fleeing and eluding when ██████████ attempted a PIT to stop the driver's dangerous driving actions.

FHP1116 and FHP1206 are both marked Florida Highway Patrol vehicles with prominent agency insignia and emergency lights / siren activated throughout this incident. Each patrol vehicle's speedometer was calibrated within the previous six months.

Due to Garza actively fleeing / attempting to elude two law enforcement officers during this incident, she is charged with the following criminal violations:
